



Head Quarters Hospital, Cuddalore on every month 1st and 3rd Thursday, Without detrimental to the inpatient and out patient service of the psychiatric wing subject to the following conditions.

- i. The Organizers should obtain permission of the Dean/ Superintendents of the District Head Quarters Hospital concerned for conducting the group meetings by giving prior notice of not less than three working days ahead of the scheduled of the meeting.
- ii. The duration of the Group meetings should last not for more than two hours and not extended beyond the office working hours.
- iii. Taking photographs or videos of the proceeding strictly prohibited
- iv. No money should be collected by the organizers from the persons participating in the Group meetings either in the form of donation or contribution.
- v. The organizers should not involve in welfare or social service like providing food, cloth, money or canvass to join in business dealing etc.
- vi. The organizers should not collect/ keep case history / records of the participants nor keep track of their attendance, offer domestic counseling or referring participants to a particular medical facility etc.
- vii. The organizers should be apolitical and desist from religious preaching/ discourses / prayers in any form.
